**INTRODUCTION TO INTERMEDIATE MEMBERSHIP RULES****Intermediate Membership:**

- (a) Males and females aged between fourteen (14) years and the Legal Drinking Age may apply to become Intermediate Members of the Club in accordance with the procedure for Ordinary Membership set out in **Rule 7.3**.
- (b) Intermediate Members shall;
- (i) be entitled to join the Club Gymnasium, Club Adjunct or Sections, and engage in activities within the Adjuncts or Sections.
  - (ii) Be bound by the Sale of Liquor Act and Club Rules.
  - (iii) Not be eligible to take part in any Membership Draws or other Club Promotions.
  - (iv) Not be eligible to take part in meetings and elections of the Club.
- (c) On reaching the Legal Drinking Age, Intermediate Members are eligible to apply for Ordinary Membership.
- (d) Members shall automatically lose their Intermediate Membership status:
- (i) three months after reaching the Legal Drinking Age; or
  - (ii) upon admission as an Ordinary Member,  
(Whichever is earlier)

**As an Intermediate Clubs of Marlborough Member you are not permitted to:**

- Sign anyone in.
- Be at the Club unsupervised after 7pm.
- Be at the Club in school uniform.
